

**TERMS & CONDITIONS 206 BOURKE STREET**  
**“Melbourne Dumpling Festival; Spend \$10 to redeem your free beverage” PROMOTION**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this **“Melbourne Dumpling Festival; Spend \$10 to redeem your free beverage”** Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on VIC local time.

**ELIGIBILITY**

2. Subject to condition 3, this Promotion is only open to Australian residents aged 14 years or over. Entrants under 18 years old must have parent/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion.
3. The following are ineligible: (i) employees of the Promoter, ISPT Pty Ltd or any of the tenants or retailers in 206 Bourke Street (**“Participating Centre”**) or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.
